REGISTR OF DOCTORS (1)

§ Act No. 20/1966, of the Legal Gazette, on care for health of the people

- **Data on doctors – employees and self-employed**
- integral part of the National Healthcare Information System
- administrator: Institute of Healthcare Information and Statistics of the Czech Republic (*organizational part of the Ministry of Health*)
- data for the register provided by doctors themselves

Register of doctors contains (2)

- a) Data necessary for identification of the doctor (personal identification number, university degree)
- b) Data on education/qualifications and specialization
- c) Data necessary for identification of the healthcare institution to which the doctor has employment or other relation (identity number of the person, name of the department)
- d) Range of the workload

RECORDS OF DOCTORS (1)

- § Act No. 95/2004 of the Legal Gazette, on conditions of gaining and acknowledgement of professional and specialized competencies for professional performance of a doctor, a dentist or a pharmacist
- I. Records of doctors integrated in specialized training or additional professional practice**
- II. Records of doctors who have achieved specialized professional qualifications**
 - Administrator: Ministry of Health

Records of doctors contain (2)

- a) Personal data (first name, surname, degree, nationality, date and place of birth, home address, (place of stay of a foreign citizen)),
- b) date and place of graduation in an accredited study programme provided within university education,
- c) number of a diploma or another certificate proving acknowledgement of the educational course abroad,
- d) name of school, study programme and branch of study
- e) date of enrolment in a specialized educational course or its cancellation,
- f) date of issue of the certificate on graduation from the basic course in the specialisation branch,
- g) date of passing the exam for specialized postgraduate certification

LIST OF CHAMBER MEMBERS (1)

§ Act No. 220/1991 of the Legal Gazette, on Czech Medical Chamber, Czech Dentists' Chamber and Czech Pharmacists' Chamber

- **List of members of the professional chamber**
- the list is administered by the respective professional chamber
- data are publicly accessible, with the exception of, above all, date of birth, address in the Czech Republic or address in the EU Member State of stay

List of members contains (3)

List of doctors: a) first name, surname, register number

b) place of work

c) specialization, licence

List of dentists: a) first name, surname,

b) date of entry in the list of members

c) reached level of professional education

d) provided health care

e) name and address of workplace and phone number

List of pharmacists: a) first name, surname

b) name and locality of the pharmacy

NON-MEDICAL HEALTHCARE PROFESSIONS

REGISTER OF NON-MEDICAL PROFESSIONALS (1)

- § Act No. 96/2004 of the Legal Gazette, on conditions for gaining and acknowledgement of qualifications for performance of non-medical healthcare professions and performance of activities related to healthcare provision and on amendments to some related acts.
- **data on non-medical healthcare workers who were awarded certificates for performance of a healthcare profession without professional supervision, and on visiting persons**
 - part of the National Healthcare Information System
 - administrator: Ministry of Health and/or National Centre for Nursing and Non-medical Healthcare Branches in Brno
 - register is publicly accessible, with the exception of data on personal identity number and permanent address

Register of non-medical workers contains (2)

- a) personal data (first name, surname, permanent address, date of birth, personal identity number)
- b) number of the certificate
- c) address of the employer and the professional job performed, or address of the non-State healthcare institution where the professional job is performed
- d) data on reached level of professional education including specialized and certified courses, the year of graduation and the country of issue
- e) date of termination of the certificate or announcement
- f) whether the person is a permanent or visiting worker
- g) date of crossing off the register
